Available Insurance Products*:

Petroleum Jobbers – coverage for petroleum jobbers who purchase their petroleum products directly from the refining companies (or in some cases from larger jobbers) and distribute to retailers, or sell them directly to the end user. In conjunction with this program, AMC will be able to write the C-stores and Card Locks.

Propane Distribution – coverage for wholesale and retail propane distribution to homes, farms, commercial establishments or factories and installation of LP gas appliances and burner assemblies.

Common & Contract Carriers – intent is to insure operators that haul petroleum products for hire or under contract; this can be the only operation or in conjunction with other operations.

Home Heating Oil Distribution – includes these operators in their capacity as wholesalers, retailers and service work. To qualify for coverage, a risk must have at least 50% of total sales generated from one or in combination with one or more of the eligible classes.

Used/Bulk Oil Haulers – covers the collection and transportation of used oil products, lubricants and other miscellaneous products, such as antifreeze.
